

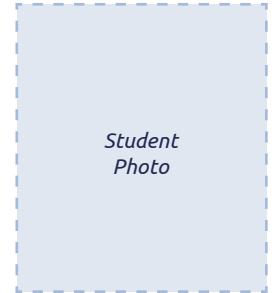

CONDITIONS OF ACCEPTANCE

1. Attendance at classes and extra-curricular activities.

Absence from school will only be allowed for health reasons or with confirmed permission from a parent or guardian. Permission must be emailed to: hovereception@ise.uk.com before the start of scheduled class times.

2. School Rules – The following rules must be observed (in the interest of all)

- a. Smoking is forbidden at all times.
- b. The consumption of alcohol and/or the taking of controlled drugs is strictly forbidden.
- c. Students must be at home in evening at the following times, except when they are attending school functions; Under 13 by 18:00
13 by 20:30, 14 - 15 by 21:30, 16 - 17 by 22:00.
- e. Students must not leave Brighton or their host families in any circumstances without written permission of their parent/guardian
- f. Students must obey British Law

Any infringement of these rules may result in a student being sent home early at their own expense, without refund of any fees.

3. Responsibility and insurance

ISE will take all reasonable precautions to ensure the safety and wellbeing of students aged under 18, but neither ISE school nor host family accommodation can accept legal responsibility for any accident, illness, theft or loss of a students' personal effects. .

Students are strongly advised to take out comprehensive personal insurance before coming to England.

4. Social Programme for Young Learners

The Young ISE programme of excursions, visits & sports are carefully organised by the school and are supervised by school staff. The programme may include coach travel, boat trips and sport.

Parents/guardians should indicate if there are any sports/activities they do not authorise their child to participate in.

An ISE group leader will accompany students on all Young ISE activities and excursions.

5. Un-supervised times

Students on the Young ISE course are supervised by the school from when they arrive in the at the school building before class at 09:15, until the end of the afternoon activity, typically at 16:30. Students are also supervised from arrival to departure of any school-organised evening activity and full day trips to other cities. During full day trips students aged 14 or over will be allocated some free time to go shopping in groups of no less than 4 students. Students are not supervised by the school on their journey to and from school or school-organised evening activities or full day trips, when students travel with their housemates using Brighton & Hove buses. Between 16:30 and 18:00 students may go into Brighton city centre unsupervised for shopping in groups of no less than 4 students.

6. Emergencies

I understand ISE staff will contact me in case of accident or emergency and that if I am unobtainable, may contact my emergency contact as appropriate.

7. Media

I understand that on occasion ISE may take photos, video or audio recordings of activities for educational and marketing purposes. I accept that media, images or video that include my child may be used on promotional material.
